#### Bethesda COVID-19 Update Saturday, 04 April 2020

We have included in this Update information on the COVID-19 situation within the Bethesda Homes and other items that may be of interest.

#### COVID-19

We are thankful that currently both the Brighton and Studley Homes are continuing to operate as usual residents and staff appear to be free from the virus symptoms at present.

At Harpenden, the three residents who were experiencing virus-related symptoms are currently no worse and are being cared for using recommended methods by Public Health England. Two further residents developed symptoms associated with the virus on Friday, 3 April 2020 and these are being monitored and cared for using the recommended methods. Families are being kept informed of the situation with their loved ones.

Staffing at Harpenden is challenging, as a number of staff are 'self-isolating' and others are either showing or have shown symptoms of the virus. In the Lord's mercy and we trust in answers to prayers, it has been possible to keep the Home functioning – it has been in proving the barrel of meal shall not waste, neither the cruse of oil fail (1 Kings 17:14-17).

#### Help needed

We are extremely grateful and thankful for the many offers of help from volunteers who have come forward at this difficult and challenging time.

As identified above, help is needed, especially from those with experience of caring, at the Harpenden Home and also at Brighton and Studley so that there is a 'bank' to call on if there is a change of situation in any of the homes.

Also 'pairs of hands' to help with 'household duties' are still needed.

We would thank those who have come forward to help and do pray the Lord will guide others to come and help Bethesda at this time.
