Bethesda COVID-19 Update Saturday, 23 May 2020

It is with "sweet gratitude" that we return thanks unto the Lord for His goodness and enduring mercy towards Bethesda.

As we look back over the past weeks, we would record how the Lord has watched over the Bethesda Homes and kept the residents and staff safe and preventing COVID-19 entering into the Brighton and Studley Homes.

Thankfully, at the Harpenden Home, the residents who have either had COVID-19 or suffered from the symptoms of the virus are recovered although, in some cases, feeling the bodily frailty of old age. The test result awaited for one of the residents has thankfully returned negative. The four residents who have been unaffected by the virus are still free from any symptoms.

The staffing situation at all three Home is currently manageable and we are thankful that there is a pool of 'bank' staff that can be drawn on when needed.

The government has heightened the emphasis on testing for COVID-19. As the testing programme is rolled out, then the Homes will be using this as part of the Bethesda's Infection Prevention and Control (IPC) procedures.

Although there has been some lifting of the 'lockdown' for individuals, there has been no indication of easing the need to restrict access to Care Homes other than to those persons who are deemed essential.

As mentioned last week, for the time being, Bethesda continues to suspend all visits from relatives and friends, unless there are emergency circumstances. The guidance that is currently in place will continue.
