#### Report of the executive committee

for the year ended 31 December 2017

The executive committee has pleasure in presenting the report and the financial statements for the year ended 31 December 2017 which have been prepared in accordance with the Charities Act 2011, the Companies Act 2006, the Memorandum and Articles of Association, and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2015).

# Achievements and performance Review of activities

#### General

It has been our pleasure during the year to assist over twenty-five churches and trusts on a range of matters including the appointment and retirement of trustees, changes to the administrative provisions of trust deeds, the appointment of the Trust as holding trustee, first registrations with the Land Registry and the sale of chapels. In some cases changes have been made to the trust deed provisions relating to the minimum number of trustees so delaying the need to appoint new trustees. Again, we would remind churches and trustees that such changes can only be made whilst the trust body is quorate. Where trustees' powers or discretion under trust deeds are lacking application has had to be made to the Charity Commission. This is necessary especially in order to facilitate the distribution of the proceeds of sale.

Following the sale of Hope Chapel, Nottingham thirty chapels benefitted in 2017 from the distribution of the sale proceeds. Both Zoar Chapel, Canterbury and Providence Chapel, West Street, Croydon closed during 2017 and in both cases applications have had to be made to the Charity Commission for necessary guidance and authority. Cave Adullam Chapel, Haslingden is also closed and we are assisting with the sale process. The increase in the rate at which closures have taken place brings great sadness. "Wilt thou not revive us again: that thy people may rejoice in thee?" (Psalm 85:6).

Financial help by way of grants paid and approved totalled £69,172 compared with £36,973 in 2016. Salem Chapel, Carshalton extended their chapel to incorporate new toilet facilities whilst the friends at Oakington have embarked on a major refurbishment for which a grant of £60,000 has been approved. Once again we would draw the attention of chapel trustees and church officers to the information on our website <a href="https://www.gospelstandard.org.uk/Assistance/Overview">https://www.gospelstandard.org.uk/Assistance/Overview</a> which contains helpful information on compliance issues. We provided one grant to assist with the removal of asbestos following an asbestos survey and agreed one grant to assist with the cost of an electrical upgrade following an electrical inspection.

The trust is authorised under its objects to lend money to a pastor, former pastor or prospective pastor of a Gospel Standard church to purchase a property for himself and his family. We asked our solicitors and accountants to examine this provision and we are advised that loans to members of the Trust will involve the Trust in a tax liability because of the provision in the Trust's governing document relating to the distribution of assets on a winding up. Changes to the Trust's constitution will therefore be necessary and these will have to be brought before the members at some future date. Meanwhile a loan has been approved for the pastor at Providence Chapel, Staplehurst.

The number of trusteeships held by the Trust at 31 December 2017 was 66 which includes 49 chapels and 6 graveyards. Funds held on behalf of charities and graveyards are detailed on pages 29 and 30. Payments have been made from Zion Chapel, Ely fund to Oakington.

#### Trust Publications

We are thankful to the Lord for the continuing demand for our books. The UK sales have held up very well despite the fact that the market for our books beyond our immediate denominational circle remains limited. It is encouraging that here and there our books are appreciated and significant sales are made to a number of non-Gospel Standard churches either for Sunday School purposes or for free distribution. Only a small number of Christian bookshops or organisations in the UK can be regarded as regular customers. It does seem that the more traditional, conservative end of the Christian book market, especially for children's books, is sadly small, and books generally are not appreciated as they once were. Nevertheless we hope that our books will prove a timely spiritual help to our readers now and again and be a means of "confirming the souls of the disciples, and exhorting them to continue in the faith" (Acts 14:22) and provide help and guidance to the children and the younger generation.

The number of books distributed fell from 14,834 (including 2,000 *Bible Doctrines* in Urdu printed in Pakistan) in 2016 to 9,585. However 2016 did include a number of special circumstances and one-off orders. The number sold in 2017 is significantly higher by 32% than in 2015 which is a more comparable year. In value terms, sales within the UK have shown a steady increase year by year over the last five years.

Our six new titles published in 2017 have been, in general, well received and all have sold in useful volumes. A number of reprints have also been undertaken. It is always satisfying when the need for a reprint arises though often wisdom is required to know when likely demand justifies this step and mistakes can be made.

Our website continues to work well attracting a very worthwhile number of orders and we do use every opportunity to draw the attention of potential customers to our web address. Online sales now make up a significant proportion of private purchases of our books. The table on the next page provides an analysis of book sales by title. The

various biographies and short accounts cover about fifty titles of which over 1,200 books related to the reformers and martyrs (407 for the life of Martin Luther).

The year 2017 marked five hundred years since Martin Luther published his ninety-five theses. To mark this notable anniversary the Trust re-published his *Exposition of the Fifty-First Psalm*. May those who read this volume also be made to feel their sin, and present to God the acceptable sacrifice of "...a broken spirit: a broken and a contrite heart." *The Christian Remembrancer* by Ambrose Serle consists of 87 brief meditations on matters pertaining to the soul experience and daily life of the Lord's people. One reader very much enjoyed this book adding "It has been both searching, instructive and comforting". Dr Robert Hawker's book of meditations *Consider Him* directs the reader to Christ in his humiliation and his sufferings through to his triumphant resurrection and the benefits which flow to sinners from his death. *The Doctrines of Grace* contains five of the lectures given by Kenneth Matrunola on the Gospel Standard thirty-five articles which especially pertain to the doctrines of grace,

often known as the five points of Calvinism. It is hoped that this book will serve to deepen understanding of these foundational truths. *David – Shepherd, Soldier, King* is the third book in the *Faithful Footsteps* series written by Mr B A Ramsbottom and illustrated by Mr M H Philpott. This series has been well received and we hope to bring out a fourth book in the series in 2018.

A continuing concern for our Publications Manager and the Committee is how to disseminate information about our books to people of all ages as there does seem to be such a lack of awareness of what we have published. Suggestions as to how to do this more effectively would be welcomed. Advertisements continue to appear in the *Gospel Standard* magazine with an occasional advertisement in *Evangelical Times* but it is difficult to gauge the impact of such advertising. Our regional agents continue to serve us well and all their efforts are much appreciated as also is the kindness of those who willingly carry books with them as they travel thus avoiding significant carriage costs. Particular thanks are due to those who are involved in the publication of our books as writer, illustrator, compiler, reviewer and supporting rôles, knowing "that your labour is not in vain in the Lord." (1 Corinthians 15:58)

#### Financial review

The total income amounted to £248,655 (page 15) which compares with £68,577 in 2016. This significant increase related to sale proceeds from Station Road Chapel, Redhill. The beneficiary of the sale proceeds was the Baptist Building Fund which kindly allocated a share of £171,891 to The Gospel Standard Trust of which 50% was for general purposes and 50% for expenditure on chapel premises. Hence we have to show a restricted fund column with income of £85,945. A major part of that has been accounted for in the grants agreed or paid out after receipt of that allocation. Other income is materially higher at £20,489. This relates principally to the recovery of professional and other costs in connection with help provided to trustees including that in relation to chapel sales.

Total expenses were £169,716 compared with £123,644 in 2016. The cost of publications was a little lower at £55,237 and the details of the Publications' activities are given in Note 8 on Page 24. The net outgoings on Publications amounted to £20,031 compared with outgoings of £12,642 in 2016. These amounts have been funded by the significant legacies received in previous years. Grant making costs on Page 15 increased by £47,168 of which the major elements are grants, up by £32,199 (see the details of grants on Page 21) and legal and professional fees. The net inflow of funds on Page 15 was £80,489 compared with an outflow of £46,617 in 2016. Total reserves at 31 December 2017 stood at £1,379,580 (Page 17) compared with £1,299,091 at 31 December 2016. The major part is held in bank deposits.

*Reserves policy*. The Trust needs reserves to fund the investments in freehold property and the book stock which are used for the Objects of the Trust and to provide working capital. Otherwise the committee, believing that all power is committed unto the Lord Jesus Christ in heaven and in earth, and that our God will supply all our need according

to his riches in glory by Christ Jesus, will seek to lay out the remaining funds for the permitted Objects of the Trust as the needs are brought before the committee and opportunity arises. The level of free reserves at 31 December 2017 was £587,694 (2016: £511,914).

Investment policy and performance. The policy regarding investment is to retain funds on deposit partly to meet requests from chapels for financial support (which is a principal purpose) and partly because of concern over equity investments and the receipt of shares in profit from unacceptable activities. The funds are spread between immediate access and term deposits in accordance with a periodic review of the access needs and allocated to a number of deposit takers to spread risk and to achieve competitive interest rates.

#### Plans for the future

If the Lord will, the Trust will continue to publish Christian books in accordance with the truth in the scriptures which we love and in accordance with the Articles of Faith of the Gospel Standard Baptists and distribute within the United Kingdom and overseas for the benefit of our congregations and the church of Christ at large of all ages. The Trust will further seek to use its funds amongst the Gospel Standard chapels as opportunity arises for the repair and improvement of buildings and otherwise. The provision of guidance and help to churches and trustees on legal and compliance responsibilities does feature prominently in our activities and this will continue as we are enabled. Brethren, pray for us.

#### Structure, governance and management

#### Legal status

The Gospel Standard Trust ("the Trust") is a company limited by guarantee and not having a share capital which was founded in 1966. Its governing documents are its memorandum and articles of association. The Trust acts as a trust corporation under a certificate granted in 2006 by the Department for Constitutional Affairs (now the Ministry of Justice) and the Trust can therefore act as a sole trustee. It is also a registered charity. The members of the executive committee are the directors for Companies Act purposes and trustees under charity legislation.

#### **Executive committee**

The maximum number permitted by the articles of association is 12 and those who have acted as members of the committee during the year are shown on page 4. In accordance with the articles of association only male members of a Gospel Standard Baptist Church who subscribe to the Articles of Faith of the Gospel Standard Strict and Particular Baptists are eligible to hold office as a member of the executive committee. The committee has power to appoint a new committee member but the appointment is subject to confirmation at the following annual general meeting. Mr P J Pocock, (South Moreton) kindly agreed during the year to help us and was appointed to the committee on 2 February 2018. He will need to be confirmed in office at the 2018 annual general

meeting. Three members of the committee retire in rotation at the annual general meeting each year but are eligible for re-election. Messrs D J Christian, M J Hyde and H Mercer retire in rotation this year and all have expressed their willingness to stand for re-election.

#### Organisational structure

The activities of the Trust are managed by the executive committee which meets at least three times a year. These meetings deal with all aspects of the Trust's activities. Further meetings are held as necessary to deal with Publications matters. The activities and the funds are divided between General matters and Publications. Publications are managed by Mr P E Skelton, who works closely with Mr J A Kingham, Publications Director, and operates from the book room in Harpenden. Subscriptions are dealt with by Mr M G Bailey, a member of the executive committee, and by Mr G L TenBroeke who is responsible for those resident in North America. Other matters are dealt with by the Trust secretary.

#### Remuneration

Remuneration for key management personnel is negotiated with the individuals concerned and is set at the National Minimum Wage or higher depending on the activities undertaken. Mr J A Kingham was remunerated for Technical IT and Publication services which is in accordance with the Memorandum of Association as amended by Special Resolution 21 May 2005 and confirmed by Order of the Charity Commission 8 September 2005.

#### Trustees' induction and training

New executive committee members (trustees) with the appropriate knowledge, experience and abilities for the Trust's activities are selected from the male members of Gospel Standard churches as required by article of association number 26. The appointment of a new trustee (executive committee member), who will be provided with an induction pack, will be subject to the prospective trustee attending a mutually satisfactory induction meeting with executive committee members and the secretary. Continuing briefing and support is provided as necessary.

#### Risk management

The committee regularly considers the major risks to which the Trust is exposed and updates the risk register and the policy for mitigating those risks. A major risk is anything that could have an adverse impact on achieving the Trust's objects or could bring the Trust into disrepute or is illegal advice or action or could bring financial or property loss. Such risks are addressed either by, if possible, eliminating the risk by ceasing the related activity, or transferring the risk to a third party or by taking action to reduce or control the risk. The two key concerns to the committee are the risks as a chapel trustee and the risks from advice given. The committee's strategy for managing those risks is to make regular contact with the churches and review their own compliance and wherever possible to ensure that advice given is supported by professional advice or other authority or covered by disclaimer.

#### Objectives and activities

The objects for which the Trust was established are set out in the objects clauses of its memorandum of association. Primarily these are to assist Gospel Standard Strict Baptist churches or congregations in the furtherance of their religion and charitable work, to assist with the appointment of trustees, legal advice, repairs and maintenance of church property and to support denominational charities and any other charitable trust or fund approved by the executive committee. In the furtherance of these objects the Trust has ancillary powers which include acting as trustee or co-trustee (including as custodian trustee) of denominational property and charitable funds, making grants and loans, assisting pastors (including former and prospective pastors) of Gospel Standard churches in the provision of living accommodation and to print and publish literature approved by the committee.

#### **Public Benefit**

The executive committee has considered the public benefit guidance issued by the Charity Commission. The work carried out by the Trust in fulfilling the Objects summarised in the preceding paragraph assists churches and trustees to continue with the regular provision of services for the public worship of God in accordance with the Holy Scriptures and the Articles of Faith of The Gospel Standard Baptists. Further, under the blessing of Almighty God, Father, Son and Holy Spirit, this work together with the publication of good books and electronic communication will bring sinners from darkness to light and establish them in the truth with the consequent benefits to themselves and others. Man's first responsibility is to God, to worship and to serve Him. Further, as it is recorded in New Testament teaching, for example Galatians Chapter 6, the result for the benefit of all should be "Let us not be weary in well doing: for in due season we shall reap, if we faint not. As we have therefore opportunity, let us do good unto all men, especially unto them who are of the household of faith."

#### **Membership**

The recorded membership stood at 258 at 31 December 2017, down by eight on the previous year. A warm welcome is extended to the five new members who joined in 2017. Ten members died during the year and three resigned or membership lapsed. The continuing loyal support of the members and the churches is greatly appreciated.

#### Statement of executive committee responsibilities

Company law requires the executive committee to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the company and of the surplus or deficit of the company for that period. In preparing those financial statements, the executive committee is required to:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;

- comply with applicable accounting standards subject to any material departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The executive committee is responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the company and to enable it to ensure that the financial statements comply with the Companies Act 2006. The financial statements have been prepared in accordance with the special provisions of the Companies Act 2006 relating to small companies. The executive committee is also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

#### **Independent examiners**

Mazars LLP were re-appointed at the annual general meeting on 20 May 2017 as independent examiners. The executive committee have continued to take advantage of Section 480 of the Companies Act 2006 which entitles the Trust to be exempted from having an audit.

# **Independent Examiner's Report to the trustees of The Gospel Standard Trust**

I report on the financial statements of The Gospel Standard Trust for the year ended 31 December 2017, which are set out on pages 15 to 28.

#### Respective responsibilities of trustees and examiner

The trustees (who are also the directors of the company for the purposes of company law) are responsible for the preparation of the financial statements in accordance with the requirements of the Companies Act 2006 ('the 2006 Act').

Having satisfied myself that the financial statements of the charity are not required to be audited under Part 16 of the 2006 Act and are eligible for independent examination, I report in respect of my examination of the charity's financial statements as carried out under section 145 of the Charities Act 2011 (the 2011 Act). In carrying out my examination I have followed the Directions given by the Charity Commission under section 145(b) of the 2011 Act.

This report, including my statement, has been prepared for and only for the charity's trustees as a body. My work has been undertaken so that I might state to the charity's trustees those matters I am required to state to them in an independent examiner's report and for no other purpose. To the fullest extent permitted by law, I do not accept or assume responsibility to anyone other than the charity and the charity's trustees as a body for my examination work, for this report, or for the statements I have made.

#### Basis of independent examiner's report

My examination was carried out in accordance with the general Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the financial statements presented with those records. It also includes consideration of any unusual items or disclosures in the financial statements, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the financial statements present a 'true and fair view' and the report is limited to those matters set out in the statement below.

In connection with my examination, which is complete, no matters have come to my attention which give me reasonable cause to believe that in any material respect:

- accounting records were not kept in respect of The Gospel Standard Trust in accordance with section 386 of the 2006 Act; or
- the financial statements do not accord with those records; or
- the financial statements do not comply with the accounting requirements of section 396 of the 2006 Act other than any requirement that the financial

statements give a 'true and fair' view which is not a matter considered as part of an independent examination; or

• the financial statements have not been prepared in accordance with the methods and principals of the Statement of Recommended Practice for accounting and reporting by charities [applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)].

I have no concerns and have come across no other matters in connection with the examination to which, in my opinion, attention should be drawn in order to enable a proper understanding of the financial statements to be reached.

#### 1 Accounting policies

#### Basis of accounting

The financial statements have been prepared on a going concern basis in accordance with the Charities Act 2011, the Companies Act 2006, the Memorandum and Articles of Association, and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) from the transition date of 31 December 2014. The Gospel Standard Trust meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note(s). Assets held in trust are not included in the balance sheet, but are set out in a separate schedule attached to the financial statements.

#### Freehold property

This comprises a share in a chapel pastor's house. No depreciation is being provided from 2015 as the property has been revalued and will be revalued each year.

#### Furniture and office equipment

Depreciation is calculated to write off the cost less estimated residual value of office equipment over three years on a straight line basis.

#### Stocks

Stocks, which are of publications, are stated at the lower of cost and net realisable value. Cost comprises the direct cost of publications with no addition for overheads. Provision for depreciation has been made in accordance with note 9 in determining net realisable value.

#### Income

Interest income is accounted for on an accruals basis whilst legacies are accounted for as income either upon receipt or where receipt is virtually certain.

#### Expenditure

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category.

#### 1 Accounting policies continued

#### Grants payable

Grants payable are payments made in furtherance of the charitable objectives of the charity. Grants are recognised upon an obligation being created in accordance with FRS 102.

#### Charitable activities

Costs of charitable activities includes grants made and direct costs in relation to publications, and an apportionment of overhead and support costs.

#### Support costs

Support costs have been allocated as a direct cost or allocated between charitable activities and governance. The analysis of overhead and support costs is shown in note 5.

#### Governance costs

Governance costs comprise all costs involving the public accountability of the charity and its compliance with regulation and good practice. These costs include costs related to a statutory independent examination together with trustees' expenses and an apportionment of overhead and support costs.

#### Funds held and their purpose

The General fund is used principally for the support of Gospel Standard chapels by way of grants and loans. The committee considers individually each application for assistance and provides a grant or loan or both depending on circumstances. The Publications fund is used for the publishing and distribution of Christian books. Legacies, donations and proceeds from chapel sales received specifically for either of those two funds are credited accordingly, otherwise such income is allocated under the discretion of the committee. The Endowment fund cannot be spent and the income is to be used for the general purposes of the Trust.

**Trustees Report for 2017** 

We have once more proved the faithfulness and goodness of the Lord in maintaining the work of the Library. The year began very quietly, but the last six months has compensated and, as before, there have not only been books borrowed but also requests for information and research in varying spheres.

The total number of books loaned is 510 - an increase of about 30%. The number of borrowers is only slightly more, but there are less this year from within the denomination. The Newsletter has continued twice a year with an accent on the Reformation and Martin Luther, being the 500th anniversary of the famous nailing of the theses in Wittenberg. The last issue also reported on more of the additions to the Library and this has resulted in several new borrowers. To help increase the circulation of the Newsletter, the G S Trust has kindly agreed to arrange for it to be included with each issue of the Gospel Standard when it is produced twice a year. We are very thankful for this assistance.

The number of new Accessions to the library is 80 this year, and in addition there are 28 duplicates. As previously we are grateful to the Gospel Standard Trust Publications, The Huntingtonian Press, Dr M J Hyde and others for gifts of new publications.

We are pleased to continue receiving donations of books over the year; some of these are additions to the Library. The sale of the remainder is about 12% less than last year, but it is always good when books go where they are appreciated rather than being discarded.

A new project has been undertaken this year of scanning all our typescript sermons so that they will be available electronically at some point in the future. To facilitate this, the Gospel Standard Trust has purchased a commercial scanner/copier for the Library, and Gordon Dadswell will be principally involved. It is still in early stages and quite a few of the sermons need to be retyped, due to poor print and/or alterations! but hopefully this problem may be limited to a particular section.

The Library also received about 70 handwritten sermon notes of Mr H Haddow who was pastor at Brockham Green – Muriel Stonelake is gradually typing these on to the computer. These may be very suitable as Prayer Meeting addresses.
