## **Report of the executive committee**

*for the year ended 31 December 2018*

The executive committee has pleasure in presenting the report and the financial statements for the year ended 31 December 2018 which have been prepared in accordance with the Charities Act 2011, the Companies Act 2006, the Memorandum and Articles of Association, and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2015).

## **Achievements and performance**

### **Review of activities**

#### *General*

The Lord has helped us through another busy year on the General side for which we are thankful. Matters have arisen with over thirty chapels involving help with the appointment of trustees (including appointing the Trust as nominee for first registration with the Land Registry), changes to the administrative provisions of trust deeds, occupation of chapel houses, provision of pastors' houses, leases, grants for repairs and chapel sales. These have involved considerable legal costs much of which is recoverable especially from the proceeds of sales. However we do contribute in some cases depending on church finances.

Difficulty has been experienced in tracing the whereabouts of some trust deeds and it is important that church officers keep these documents safe. Assistance has been given to the churches at Attleborough and Brighton so that trust funds connected with their chapels could be used to help with the acquisition of houses for their pastors. The Charity Commission was very helpful in making this possible. We have also found the Charity Commission willing to assist with the sales of closed chapels where powers in the trust deeds are insufficient. In four cases during the year, Zoar Chapel, Reading, Cave Adullam Chapel, Haslingden, Zoar Chapel, Canterbury and Providence Chapel, West Street, Croydon the Commission has accepted the trustees representations to allow the sale proceeds to be distributed as well as income arising. The sale of Zoar Chapel, Reading completed in February 2018 whilst the other three sales should all complete in 2019.

Further help and guidance has been given on compliance matters. A circular was sent round to chapel correspondents in May 2018 concerning the new General Data Protection Regulation. Visits have been made to two chapels to give guidance on health and safety issues. The Trust has had a representative attend twelve trustees' meetings during the year. Grants paid out to help with chapel renovations totalled over

£80,000. In view of the funds available from chapel sales this is expected to be much lower in 2019.

March 2021 is the date when the exception for churches' working funds from registration with the Charity Commission ends. In 2019 we hope to agree the format of a Model Constitution with the Charity Commission for use by the churches. The number of trusteeships held by the Trust at 31 December 2018 was 68 which includes 52 chapels and 6 graveyards. Funds held on behalf of charities and graveyards are detailed on pages 29 and 30. Further payments have been made from Zion Chapel, Ely fund to Oakington.

### *Trust Publications*

We would again give thanks to the Lord for maintaining the work of Publications. The sales have held up well which, in the light of the increasing secularisation of Western society and the hostility in parts of the Evangelical world to anything Gospel Standard related, is a cause for much gratitude. Sales to North America remain healthy – indeed, we are very dependent on this market, almost all of these sales being through Gospel Mission Books. Sales to the Netherlands (always irregular and unpredictable) have jumped again, with some significant orders, though sales elsewhere in the world remain minimal.

The number of books distributed fell from 9,585 in 2017 to 8,631. In value terms, the upward trend in sales over the past five years has continued which is a cause for much gratitude. We reprinted *Mary Jones and Her Bible* (500 copies), *Kept Safely in the Darkest Night* (300 copies) and *Divine Guidance* (200 copies) during the year. It is always satisfying when the need for a reprint arises though often wisdom is required to know when likely demand justifies this step and mistakes can be made.

Our website continues to work well and online sales now make up a significant proportion of private purchases of our books. Every opportunity is used to draw the attention of potential customers to our web address.

Four new titles were published in 2018 and are selling steadily. *The Life and Ministry of Clement Wood* contains an account of his life, much in his own words, together with a selection of sermons and examples of addresses and other correspondence. Many of us have fond memories of Mr Wood and his ministry. At least 450 copies have been sold so far including sales in early 2019. Alfred Dye's *Seeking the Mind of the Spirit* contains expositions of twenty-six "difficult" portions of Scripture. This was not published in his lifetime but has been preserved as a manuscript and is now in the possession of the Gospel Standard Baptist Library. The Librarians there transcribed the manuscript and it is now published for the first time with the kind permission of the Library trustees. *Behold the Lamb* is a collection of forty-one of J K Popham's prayer meeting addresses which were taken down in shorthand during his ministry and have only relatively recently been transcribed. Alongside the autobiography of John

Kemp, first pastor of Ebenezer Chapel, Biddenden, *By Faith* also includes some of his previously unpublished letters and sermons.

The table below provides an analysis of book sales by title. The various biographies and short accounts cover about fifty titles. Various books of sermons and daily portions includes 192 copies of J C Philpot's books *Ears from Harvested Sheaves* and *Through Baca's Vale* which have both been reprinted a number of times over the years.

The *Faithful Footsteps* series written by Mr B A Ramsbottom and illustrated by Mr M H Philpott continues to be well received. We hope to bring out another book in the series, this time on *Mordecai – the Man with a Secret* with an accompanying *Sketches* in 2019. Following the publication of Martin Luther's *Exposition of the Fifty-First Psalm*, we hope to publish another of his expositions in 2019 this time on John 17. May the Lord's blessing rest on these ventures.

A continuing concern for our Publications Manager and the Committee is how to disseminate information about our books to people of all ages as there does seem to be such a lack of awareness of what we have published. The Publications Manager would welcome suggestions on how to do this more effectively. We wish to acknowledge the goodness of God in maintaining us through another year. Our regional agents continue to serve us well and all their efforts are much appreciated. Particular thanks are due to all those who are involved in the publication of our books knowing “that your labour is not in vain in the Lord.” (1 Corinthians 15:58)

### **Financial review**

The total income amounted to £96,366 (page 15) which compares with £248,655 in 2017. No amounts were received in 2018 from chapel sales. The restricted fund, which arose in 2017 from the sale of Station Road Chapel, Redhill, has been reduced to just £1,285 by a grant for chapel renovation. Other income has doubled to £41,851. This relates mainly to the recovery of professional and other costs in connection with help provided to trustees including that in relation to chapel sales.

Total expenses were £143,490 compared with £169,716 in 2017. The cost of publications was a little lower at £55,034 and the details of the Publications’ activities are given in Note 8 on Page 24. The net outgoings on Publications amounted to £16,901 compared with £20,031 in 2017. Grant making costs on Page 15 decreased by £26,023 of which the major elements are grants, down by £46,064 (see the details of grants on Page 21) and legal and professional fees which are up significantly at £43,437 (see Note 5 on Page 22). The net outflow of funds on Page 15 was £47,124 compared with an inflow of £80,489 in 2017. Total reserves at 31 December 2018 stood at £1,332,456 (Page 17) compared with £1,379,580 at 31 December 2017. The major part is held in bank deposits.

*Reserves policy.* The Trust needs reserves to fund the investments in freehold property and the book stock which are used for the Objects of the Trust and to provide working capital. Otherwise the committee, believing that all power is committed unto the Lord Jesus Christ in heaven and in earth, and that our God will supply all our need according to his riches in glory by Christ Jesus, will seek to lay out the remaining funds for the permitted Objects of the Trust as the needs are brought before the committee and opportunity arises. The level of free reserves at 31 December 2018 was £579,566 (2017: £587,694).

*Investment policy and performance.* The policy regarding investment is to retain funds on deposit partly to meet requests from chapels for financial support (which is a principal purpose) and partly because of concern over equity investments and the receipt of shares in profit from unacceptable activities. The funds are spread between immediate access and term deposits in accordance with a periodic review of the access needs and allocated to a number of deposit takers to spread risk and to achieve competitive interest rates.

## **Plans for the future**

If the Lord will, the Trust will continue to publish Christian books in accordance with the Truth in the Scriptures which we love and in accordance with the Articles of Faith of the Gospel Standard Baptists and distribute within the United Kingdom and overseas for the benefit of our congregations and the church of Christ at large of all ages. The Trust will further seek to use its funds amongst the Gospel Standard chapels as opportunity arises for the repair and improvement of buildings and otherwise. The provision of guidance and help to churches and trustees on legal and compliance responsibilities does feature prominently in our activities and this will continue as we are enabled. Brethren, pray for us.

## **Structure, governance and management**

### **Legal status**

The Gospel Standard Trust (“the Trust”) is a company limited by guarantee and not having a share capital which was founded in 1966. Its governing documents are its memorandum and articles of association. The Trust acts as a trust corporation under a certificate granted in 2006 by the Department for Constitutional Affairs (now the Ministry of Justice) and the Trust can therefore act as a sole trustee. It is also a registered charity. The members of the executive committee are the directors for Companies Act purposes and trustees under charity legislation.

### **Executive committee**

The maximum number permitted by the articles of association is 12 and those who have acted as members of the committee during the year are shown on page 4. In accordance with the articles of association only male members of a Gospel Standard Baptist Church who subscribe to the Articles of Faith of the Gospel Standard Strict and Particular Baptists are eligible to hold office as a member of the executive committee. The committee has power to appoint a new committee member but the appointment is subject to confirmation at the following annual general meeting. Three members of the committee retire in rotation at the annual general meeting each year but are eligible for re-election. Messrs S A Hyde, J A Kingham and T J Parish retire in rotation this year and all have expressed their willingness to stand for re-election. Mr M G Bailey retired from the Committee through ill health on 7 September 2018. He gave twenty two years of valuable service which included dealing with subscriptions and also chapel insurance for five years until this was discontinued in 2002. May he and his wife know much of the Lord’s presence.

### **Organisational structure**

The activities of the Trust are managed by the executive committee which meets at least three times a year. These meetings deal with all aspects of the Trust’s activities. Further meetings are held as necessary to deal with Publications matters. The activities and the funds are divided between General matters and Publications. Publications are managed by Mr P E Skelton, who works closely with Mr J A Kingham, Publications

Director, and operates from the book room in Harpenden. Subscriptions are now dealt with by the Trust secretary following Mr Bailey's retirement, and by Mr G L TenBroeke who is responsible for those resident in North America. Other matters are dealt with by the Trust secretary. The Committee is still seeking a person suitably equipped to support and eventually succeed the secretary.

### **Remuneration**

Remuneration for key management personnel is negotiated with the individuals concerned and is set at the National Living Wage or higher depending on the activities undertaken. Mr J A Kingham was remunerated for Technical IT and Publication services which is in accordance with the Memorandum of Association as amended by Special Resolution 21 May 2005 and confirmed by Order of the Charity Commission 8 September 2005.

### **Trustees' induction and training**

New executive committee members (trustees) with the appropriate knowledge, experience and abilities for the Trust's activities are selected from the male members of Gospel Standard churches as required by article of association number 26. The appointment of a new trustee (executive committee member), who will be provided with an induction pack, will be subject to the prospective trustee attending a mutually satisfactory induction meeting with executive committee members and the secretary. Continuing briefing and support is provided as necessary.

### **Risk management**

The committee regularly considers the major risks to which the Trust is exposed and updates the risk register and the policy for mitigating those risks. A major risk is anything that could have an adverse impact on achieving the Trust's objects or could bring the Trust into disrepute or is illegal advice or action or could bring financial or property loss. Such risks are addressed either by, if possible, eliminating the risk by ceasing the related activity, or transferring the risk to a third party or by taking action to reduce or control the risk. The two key concerns to the committee are the risks as a chapel trustee and the risks from advice given. The committee's strategy for managing those risks is to make regular contact with the churches and review their own compliance and wherever possible to ensure that advice given is supported by professional advice or other authority or covered by disclaimer.

### **Objectives and activities**

The objects for which the Trust was established are set out in the objects clauses of its memorandum of association. Primarily these are to assist Gospel Standard Strict Baptist churches or congregations in the furtherance of their religion and charitable work, to assist with the appointment of trustees, legal advice, repairs and maintenance of church property and to support denominational charities and any other charitable trust or fund approved by the executive committee. In the furtherance of these objects the Trust has ancillary powers which include acting as trustee or co-trustee (including

as custodian trustee) of denominational property and charitable funds, making grants and loans, assisting pastors (including former and prospective pastors) of Gospel Standard churches in the provision of living accommodation and to print and publish literature approved by the committee.

### **Public Benefit**

The executive committee has considered the public benefit guidance issued by the Charity Commission. The work carried out by the Trust in fulfilling the Objects summarised in the preceding paragraph assists churches and trustees to continue with the regular provision of services for the public worship of God in accordance with the Holy Scriptures and the Articles of Faith of The Gospel Standard Baptists. Further, under the blessing of Almighty God, Father, Son and Holy Spirit, this work together with the publication of good books and electronic communication will bring sinners from darkness to light and establish them in the truth with the consequent benefits to themselves and others. Man's first responsibility is to God, to worship and to serve Him. Further, as it is recorded in New Testament teaching, for example Galatians Chapter 6, the result for the benefit of all should be "Let us not be weary in well doing: for in due season we shall reap, if we faint not. As we have therefore opportunity, let us do good unto all men, especially unto them who are of the household of faith."

### **Membership**

The recorded membership stood at 252 at 31 December 2018, down by six on the previous year. A warm welcome is extended to the four new members who joined in 2018. Eight members died and two resigned. The continuing loyal support of the members and the churches is greatly appreciated.

### **Statement of executive committee responsibilities**

Company law requires the executive committee to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the company and of the surplus or deficit of the company for that period. In preparing those financial statements, the executive committee is required to:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- comply with applicable accounting standards subject to any material departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The executive committee is responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the company and to enable it to ensure that the financial statements comply with the Companies Act 2006. The financial statements have been prepared in accordance with the special provisions of the Companies Act 2006 relating to small companies. The executive

committee is also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

**Independent examiners**

Mazars LLP were re-appointed at the annual general meeting on 19 May 2018 as independent examiners. The executive committee have continued to take advantage of Section 480 of the Companies Act 2006 which entitles the Trust to be exempted from having an audit.

## **Independent Examiner's Report to the members of The Gospel Standard Trust**

I report on the financial statements of the charity for the year ended 31 December 2018, which are set out on pages 15 to 28.

### **Respective responsibilities of trustees and examiner**

The trustees (who are also the directors of the company for the purposes of company law) are responsible for the preparation of the financial statements in accordance with the requirements of the Companies Act 2006 ('the 2006 Act').

Having satisfied myself that the financial statements of the charity are not required to be audited under Part 16 of the 2006 Act and are eligible for independent examination, I report in respect of my examination of the charity's financial statements as carried out under section 145 of the Charities Act 2011 (the 2011 Act). In carrying out my examination I have followed the Directions given by the Charity Commission under section 145(b) of the 2011 Act.

This report, including my statement, has been prepared for and only for the charity's trustees as a body. My work has been undertaken so that I might state to the charity's trustees those matters I am required to state to them in an independent examiner's report and for no other purpose. To the fullest extent permitted by law, I do not accept or assume responsibility to anyone other than the charity and the charity's trustees as a body for my examination work, for this report, or for the statements I have made.

### **Basis of independent examiner's report**

My examination was carried out in accordance with the general Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the financial statements presented with those records. It also includes consideration of any unusual items or disclosures in the financial statements, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the financial statements present a 'true and fair view' and the report is limited to those matters set out in the statement below.

In connection with my examination, which is complete, no matters have come to my attention which give me reasonable cause to believe that in any material respect:

- accounting records were not kept in respect of The Gospel Standard Trust in accordance with section 386 of the 2006 Act; or
- the financial statements do not accord with those records; or

- the financial statements do not comply with the accounting requirements of section 396 of the 2006 Act other than any requirement that the financial statements give a 'true and fair' view which is not a matter considered as part of an independent examination; or
- the financial statements have not been prepared in accordance with the methods and principals of the Statement of Recommended Practice for accounting and reporting by charities [applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)].

I have no concerns and have come across no other matters in connection with the examination to which, in my opinion, attention should be drawn in order to enable a proper understanding of the financial statements to be reached.

### 1 Accounting policies

#### *Basis of accounting*

The financial statements have been prepared on a going concern basis in accordance with the Charities Act 2011, the Companies Act 2006, the Memorandum and Articles of Association, and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) from the transition date of 31 December 2014. The Gospel Standard Trust meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note(s). Assets held in trust are not included in the balance sheet, but are set out in a separate schedule attached to the financial statements.

#### *Freehold property*

This comprises a share in a chapel pastor's house. No depreciation is being provided from 2015 as the property has been revalued and will be revalued each year.

#### *Furniture and office equipment*

Depreciation is calculated to write off the cost less estimated residual value of office equipment over three years on a straight line basis.

#### *Stocks*

Stocks, which are of publications, are stated at the lower of cost and net realisable value. Cost comprises the direct cost of publications with no addition for overheads. Provision for depreciation has been made in accordance with note 9 in determining net realisable value.

#### *Income*

Interest income is accounted for on an accruals basis whilst legacies are accounted for as income either upon receipt or where receipt is virtually certain.

#### *Expenditure*

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category.

### **1 Accounting policies continued**

#### *Grants payable*

Grants payable are payments made in furtherance of the charitable objectives of the charity. Grants are recognised upon an obligation being created in accordance with FRS12.

#### *Charitable activities*

Costs of charitable activities includes grants made and direct costs in relation to publications, and an apportionment of overhead and support costs.

#### *Support costs*

Support costs have been allocated as a direct cost or allocated between charitable activities and governance. The analysis of overhead and support costs is shown in note 5.

#### *Governance costs*

Governance costs comprise all costs involving the public accountability of the charity and its compliance with regulation and good practice. These costs include costs related to a statutory independent examination together with trustees' expenses and an apportionment of overhead and support costs.

#### *Funds held and their purpose*

The General fund is used principally for the support of Gospel Standard chapels by way of grants and loans. The committee considers individually each application for assistance and provides a grant or loan or both depending on circumstances. The Publications fund is used for the publishing and distribution of Christian books. Legacies, donations and proceeds from chapel sales received specifically for either of those two funds are credited accordingly, otherwise such income is allocated under the discretion of the committee. The Endowment fund cannot be spent and the income is to be used for the general purposes of the Trust.

## **Trustees Report for 2018**

Another year has proved the faithfulness and goodness of the Lord in maintaining the work of the Library. Overall it has been a quieter year, but books have been borrowed steadily throughout, and requests for information and research in varying spheres continues.

The total number of books loaned was 420 - a decrease from last year when we exceeded 500. The number of borrowers has remained about the same. The Newsletter has continued twice a year with an accent on the importance of reading, particularly as there is now a selection of some of the works of the Puritans in Paperback making them more accessible to the ordinary reader. A number of these have been high-lighted as being recent additions to the Library.

There were 87 new Accessions to the library this year, and in addition there were 21 duplicates. As previously we are grateful to the Gospel Standard Trust Publications, The Huntingtonian Press, Dr M J Hyde and others for gifts of new publications.

We are pleased to continue receiving donations of books over the year; some of these are additions to the Library. The sale of the remainder is about the same as last year, but it is always good when books go where they are appreciated rather than being discarded.

The project of scanning all our typescript sermons has progressed well and Mr Gordon Dadswell has been chiefly responsible. Quite a few of the sermons needed to be retyped due to poor print and/or alterations! This is quite time consuming but thankfully, with a few exceptions, this problem has been limited to a particular section. The sermons of the following ministers have now been scanned: Messrs. J Delves, S Delves, F L Gosden, J H Gosden, J K Popham, J Raven, J W S Tyler and J W Walder.

Most of these have been uploaded on to the Gospel Standard website and are available to be accessed and downloaded if required. We are very grateful to Mr Stephen Dadswell who has done this under the direction of Mr John Kingham.
