Are there any fire / smoke alarms, and have they been tested?		
Is there any fire-fighting equipment (fire extinguishers, fire blankets e.g.) provided?		
Has the fire-fighting equipment been tested at the intervals recommended by the manufacturer?		
Are any combustible materials stored safely and away from exits?		
Has the fixed electrical system been tested by a qualified electrician (normally every 5 years) and a certificate obtained?		
Have all portable electrical appliances been tested regularly (recommended every 5 years by an electrician)?		
Portable appliances: on a visual inspection of sockets and cables, are there any signs of damage? are there any trailing leads to cause a hazard? are appliances switched off out of hours?		
All heating appliances: is the risk from high surface temperatures controlled?		
Are any gas or oil boilers inspected and regularly serviced?		
If there are any gas, coke or oil burning appliances, has a carbon monoxide detector been fitted and tested?		
Is the first aid box sufficient and up-to-date?		
Is the chapel Insurance up-to-date? Is the employer's liability insurance certificate displayed?		
Has an asbestos review been done and are the records readily available?		
Are the premises and its content kept clean, especially toilets and kitchens?		
Are the access paths level, well maintained and well lit?		
Are gravestones and graveyard paths safe?		
For Sunday schools, is a safeguarding policy in place?		
Are all measures reviewed before events such as weddings and funerals, if increased attendance is expected?		
If there is a chapel house not occupied by a pastor or caretaker, has professional advice on rental terms been obtained?
